**a) SUFFOLK COUNTY COUNCILLOR MR RICHARD SMITH**

**SUFFOLK COASTAL DISTRICT COUNCILLORS T. J. HAWORTH &  
MARRIANNE FELLOWES**

There is still time to complete the race to fill in a special survey aimed at all sports clubs in Suffolk Coastal and Waveney that will help the two Councils provide even better support in the future. The outline audit is aimed at all clubs, however big or small, and whatever age groups, they are serving. The information we are seeking is very important as it will help us tailor our resources to meet specific needs of local clubs. Suffolk Coastal's active communities team have hosted special development and information nights for clubs in their district and have online a Sports Funding Directory and a Sports Club Directory these guides can be found on [www.suffolkcoastal.gov.uk/yourfreetime/sportsclubs/](http://www.suffolkcoastal.gov.uk/yourfreetime/sportsclubs/) and provide local contacts for over 50 sports or details of around 200 different local, regional and national organisations that can be contacted for funding.

**CHANGES TO COUNCIL TAX/COUNCIL TAX BASE**

A lot of time over Christmas and New Year period has been about the changes to

Council Tax Benefit which will be New Local Council Tax Reduction Scheme as from April 2013.

I have with me a Q&A document for you along with a copy of the presentation that was held this morning.

Council Tax Benefit is currently paid to people on low income to help them pay their Council Tax bill. At the moment Government gives Councils funding to pay for all Council Tax Benefits in full. As part of the Government's welfare reform programme and the need to reduce the nation's debt, the Government has decided to change a number of benefits which includes the current Council Tax Benefit scheme, which will stop at the end of March 2013.

Instead, the Government expects Councils to introduce a New Council Tax Reduction Scheme that will replace Council Tax Benefit and to introduce the changes as from 1<sup>st</sup> April 2013. The new scheme will receive 10% less in funding from central Government, with less funding we will not be able to offer everyone the same level of support they get now. Pensioners are fully protected.

#### HOUSING BENEFIT CHANGES

From April 2013 the Government is introducing a 'size criteria' for new and existing working age tenants which will limit how many bedrooms your family will receive benefit for.

Working age tenants (those below the Pension Credit age) may lose part of their Housing Benefit if they are deemed to be under occupying the property.

#### b) LOCAL POLICE

#### Leiston and Aldeburgh Priorities

- Tackle Anti Social Behaviour around Sizewell Road, Grimsey Road, Eastward Ho and Sylvester Road in Leiston
- Crag Path Fisherman's Huts harden the area of Crag Path by working with town/district council and the fishermen themselves.
- Parking and Road Safety - Target illegal parking in Leiston and Aldeburgh. Attend schools and promote the importance of road safety.

#### **Road Safety**

The Be Bright Be Seen Campaign will continue through into the New Year.

We still have a couple of spaces left on 23<sup>rd</sup> January 2013 for The Grand Driver

Scheme at the Community Centre, Kings Field, Aldeburgh between 10.00 am and 12.30 p.m. The aim of scheme is to enable older people to identify issues relating to driving and to receive assistance with refreshing skills and adopting coping strategies to safely maintain independence.

#### c) COASTAL PROTECTION - MR MIKE CHANDLER

##### Thorpeness erosion response works

Following a joint site inspection S.C.D.C. have confirmed scope and funding for additional Phase 2 works comprising gabion rock infill, fence repairs and Benthills permanent beach access. No further community financial contributions will be required. J. Breheny Contractors Ltd are expected on site Feb/Mar 2013 and adjacent residents will be notified when dates are known.

##### Shoreline Management Plan

The draft change in policy remains with interested organisations for consideration. This is expected to take some months. There will be more information to share once consensus is reached in principle. Overall progress is positive.

##### Village Review - Coastal Plan

The 2<sup>nd</sup> November Parish Meeting identified coastal issues for on-going action including better understanding of future trends, beach re-charge, dredging and Sizewell impacts. Volunteers expressed interest in forming a community coastal group in mid 2013, ideally when current work on protection, SMP policy and Sizewell liaison has reached a firm basis for going forward.

##### Cliffs towards Thorpeness

Concern has been expressed in the parish about recent minor collapse and whether toe protection could be provided. Unusually both the land and foreshore are privately owned and are unlikely to attract public funding for coastal protection against normally applied criteria. However the Phase 2 scheme has installed a buried toe protection to avoid outflanking in the corner beyond the gabions, and a small groyne to encourage accretion. Further north the policy would remain as no active intervention with natural cycles of toe scour and crest retreat. Allowing for sea level rise the SMP predicts a loss of 10 - 30 m averaged over 100 years. This is highly dependent on the extent to which the beach height is maintained and the coastal group may wish to consider options.

#### d) SIZEWELL POWER STATIONS - MR MIKE CHANDLER

##### Sizewell Stakeholder Group and emergency planning zones

The full SSG meeting was attended on 6<sup>th</sup> December 2012

Arrangements have been made for Andy Osman, Head of Emergency Planning at SCC to update Parish Council Meetings at Knodishall on 16<sup>th</sup> January and Aldringham-cum-Thorpe on 11<sup>th</sup> February 2013. Risk Assessment for Sizewell B indicates a possible 1km detailed emergency planning zone following the A Station shutdown. The key question for the consultation is whether, in the light of national and international assessment, it is proposed to widen the historic 2.4m DEPZ to

include parishes not previously affected by health and planning provisions (aside from an extendable zone for an extreme event). The consultation period ends 8<sup>th</sup> April 2013.

### Sizewell C Consultation

The Sizewell C Community Forum was attended on 13<sup>th</sup> December 2012.

Work is underway with EDF and SCDC to establish on-going liaison with the community regarding mutually interactive coastal schemes and processes.
