Ban of Sky Lanterns/Balloon Release

As you may have seen in the media, SCDC'S Cabinet recently received widespread public support after it voted unanimously to ban the mass release of balloons and sky lanterns from our land.

The ban will be included within the terms for leasing Suffolk Coastal land in the future. Other Councils across the country already have bans in place and it is hoped that many others will follow suit.

Individual Electoral Registration (IER) is here!

The new system for registering to vote was introduced this week (from Monday 10th June). Individual Electoral Registration (IER) means every individual will be responsible for their own registration instead of using a household form to register to vote.

This is the biggest change to how people register to vote in almost a hundred years but most people on the current register will be automatically transferred to the IER register without having to do anything.

The Government is introducing IER will make registering to vote safer and more convenient. Instead of using a household form to register to vote, everyone will take individual responsibility for their own registration.

In order to apply, a person will need to provide their National Insurance Number and date of birth. With IER, for the first time, people will also be able to register online. IER will make registering to vote safer and more convenient.

From June (or September in Scotland) any new application to register will be made individually. It can be made online at www.gov.uk/register-to-vote or on a paper form.

Suffolk Coastal Disability Forum – Suffolk Coastal Disability Forum provides a place where everyone who wants to make a difference to the lives of disabled people in the Suffolk Coastal area can meet, be involved, and have their say.

Various groups and individuals who are active in this area receive an invitation to meetings – but they are open to everyone who has an interest in disability issues.

Recent meeting included discussions with representatives from Greater Anglia, Ipswich Buses, Community Transport, and taxi licensing in Suffolk Coastal.

There were lively exchanges on such issues as:

- Bus routes and accessible buses;
- Wheelchairs and pushchairs on buses;
- Talking buses;
- Access to trains – and even the London Underground;
- Dial-a-Ride services and accessible taxis;
- Transport to hospitals.

The next meeting will debate the transport difficulties of disabled people, including discussions with representatives from Suffolk County Council, and also look at issues regarding parking for Blue Badge holders in Supermarket car parks – a hot topic indeed with representatives of Tesco's at Martlesham attending.

Benefit Fraud

As you may have also read or seen in the media last week a former Martlesham Heath woman has pleaded guilty to a string of benefit frauds, lasting well over a decade, which netted her over £140,000.

The woman who had previously pleaded guilty to 9 offences, appeared before Ipswich Crown Court on Thursday, 5th June 2014 and was given an 18 month suspended prison sentence, suspended for 2 years, and a six-month curfew (to run between 7pm and 6 pm). She will also have to repay all the money she obtained through her dishonesty.

A joint investigation was launched between Suffolk Coastal's Corporate Counter-Fraud Unit and Department for Work and Pensions investigators, which resulted in her homes being raided by Essex Police – and evidence seized, including film and photographs of her enjoying an active life and holidaying abroad.

Community Infrastructure Levy Charging Schedule

The Community Infrastructure Levy (CIL) is a new standard charge which local authorities in England and Wales can charge on most types of new development in their area. The funds collected through CIL will be used to help fund the infrastructure needed to support the development planned in the Suffolk Coastal District Local Plan.

Currently the Council collects contributions from developers through Section 106 planning obligations. These contributions help deliver improvements to infrastructure such as open space, schools and transport works. Have you say on Conservation plans

Local people are being asked to have their say on the plans to help conserve six areas within Suffolk Coastal.

The draft conservation area appraisals for Bramfield, Easton, Great Glemham, Leiston, Marlesford and Snape Maltings are now available for comment.

There are currently thirty-four conservation areas in the Suffolk Coastal District. Conservation areas are defined as 'areas of special architectural or historic interest the character or appearance of which it is desirable to preserve or enhance'.

The conservation area appraisals identify the particular features which justify its status and include:

- a definition of the special character of the conservation area through its Special qualities, such as layout, uses, architecture, setting, open spaces, topography and archaeology.
 - an analysis of the area's history, development and current status
 - a guide to managing future changes
- The purpose of the appraisals is to define the conservation areas' character and appearance, while providing guidance for managing future change in the area for the benefit of occupiers.

The documents provide useful planning guidance for those who want to promote change, as well as the planning department and councillors. The draft appraisals will replace the existing ones for Bramfield, Easton, Great Glemham and Marlesford that date from 1999 and Leiston that dates from 2002.
