Views sought on anti-social behaviour controls

East Suffolk Council is asking local people for their views on anti-social behaviour controls. Over the last year, Public Space Protection Orders (PSPOs) have replaced the designed Public Place Orders (DPPOs) in the district due to the Anti-Social Behaviour, Crime and Policing Act 2104.

During the process, East Suffolk Council has been in discussion with Suffolk Police to review the PSPOs and is now questioning whether they are still needed.

The consultation is running from 7th May until 17th June and the Council wants to hear the views of local residents and businesses.

Man found guilty of littering in Leiston

A man has been fined more that £200.00 after being found guilty of a littering offence. At the hearing in Ipswich Magistrates Court on 16th April a man was charged with littering following an incident last year.

On 6th September 2018, the person was witnessed throwing a cigarette end on the ground in Valley Road, Leiston before driving away. The incident was reported to Norse and they issued a £80.00 fixed penalty notice which was not paid, despite being sent reminders. The resident, who did not attend his court hearing, was found guilty of littering and was ordered to pay a total of £230.00, comprising of £100.00 compensation and £100.00 for costs £30.00 for the victim surcharge.

The project will be delivered over three stage process:

- 1. Gather information and data to analyse the current situation and speak to local people in the industry to get their views.
- 2. Look at different options to determined what can be done to improve the fishing opportunities, including bringing more jobs to the region and revitalise the industry;
- 3. Finally, create a clear plan to deliver the necessary changes needed in East Anglia.

If everything goes to plan the next step will be the submission of plans and paperwork to the Planning Inspectorate who anticipated a period of approximately three months before the final decision is made.
