#### b) THE ENERGY COAST - Mr Bill Halford

Bill kindly came along and gave us a small presentation on all the information he has with regards to the Nautilus Interconnector and EuroLink Interconnector Projects.

Nautilus are proposing a second Interconnector between Great Britain and Belgium and EuroLink is proposing a second Interconnector between Great Britain and the Netherlands and both of these include cabling and a converter Station are to be situated in East Suffolk. Nautilus is currently at a very early stage of its development and should consent be granted a final investment decision is planned for 2024 followed by construction commencing in 2028. These proposals could have serious impact to our parish.

He also reported on the latest with ScottishPower Renewables EA TWO and EA ONE and Sizewell C.

#### c) SCOTTISHPOWER RENEWABLES

They are expecting to submit their application for the EA TWO and ONE North offshore windfarms later this year and following the acceptance by PINs they would like to display documents in locations for public access. The Parish Council agreed to receive these and will also hold onto the previous PEIR documentation.

#### d) SIZEWELL POWER STATIONS

The response to Stage 4 Consultation is currently being compiled and will be returned by 27<sup>th</sup> September 2019.
