3. MINUTES

4. REPORTS

a) SUFFOLK COUNTY COUNCIL – COUNCILLOR RUSS RAINGER

A major review of the way highways in Suffolk are maintained has been launched by the new Councillor Mary Evans she is responsible for the county's 4000 miles of roads.

The views of local businesses, town, parish, district and borough councils and the public will be taken into account as part of the review.

b) SUFFOLK COASTAL DISTRICT COUNCIL – COUNCILLORS T.J. HAWORTH-CULF & MAUREEN JONES

T.J and other cabinet colleagues attended the annual LGA Conference in Birmingham. It was apparent from listening to other councillors that they share our concerns regarding adult social care in the future years and especially the numbers of LAC within the district and county – finding ways of getting children out of care and into family life.

Amendment to the Licensing of Houses in Multiple Occupation

The term House in Multiple Occupation (HMO) is used to describe a dwelling in which several different households, who are not members of the same family, live. HMOs include shared houses, bedsits, hostels and staff accommodation where there is some sharing of kitchens, bathrooms and living rooms. There are currently 25 licensed HMO's in East Suffolk; 17 in Suffolk Coastal and 8 in Waveney. The best estimate at this stage is an increase of between 200 and 300 HMO properties across East Suffolk.

Public Spaces Protection Order – Felixstowe Beach Dog Controls:

In November 2017, Cabinet considered a report recommending the adoption of a number of PSPOs, one of which was to replace the existing byelaw which prohibits dogs on the beach at Felixstowe over the summer months. Cabinet agreed to further local consultation on an alternative proposal, put forward by Felixstowe Town Council, extending the area of the restriction to include the beach from Manor End to Cobbold's Point but reducing the time that dogs are excluded to between 10 am and 6pm during the summer months (1 May to 30 September). Further consultation was carried out on the original proposal and the alternative suggested by the Town Council. The result show that, although there was some support for the alternative proposal, the clear preference was to maintain the status quo with a ban on dogs on the area of beach northwards from the groyne between Manwick Road and Arwela Road to the groyne opposite the south-eastern corner of the Spa Pavilion, between 1 May and 30 September.

Suffolk Coastal District Council Local Plan – First Draft Local Plan:

The Local Plan sets out the level of growth which needs to be planned in Suffolk Coastal and identifies where that growth should be located and how it should be delivered. The plan sets out the planning policies which the Council will use to determine planning applications in its area. The First Draft Local Plan is a comprehensive document which includes planning policies and site allocations. It will replace the existing Local Plan for Suffolk Coastal which consists of a number of individual documents that have been prepared and adopted by the Council in recent times Cabinet is requested to agree the First Draft Plan and appendices which are available at:

The independent Local Government Boundary Commission for England is asking people to comment on plans for council ward boundaries for the new East Suffolk Council. The commission launched an eight week consultation on its proposals for the new wards on Tuesday 3rd July 2018. It wants to hear local views on the proposals before finalises them in October. The consultation runs until 27th August 2018. Work is due to take place probably from Tuesday onwards regarding the events from storm Emma.

Deben Leisure Centre is off to a great start

The newly reopened Deben Leisure Centre is off to a great start as large numbers of people visit the centre to try out the start-of-the-art facilities. There was a great turnout for the

opening week with over 1300 people diving into the pool and the new gym being put through its paces. In total, over a whopping 2000 people visited in the first week alone.

Suffolk Waste Partnership Road Litter Campaign:

Fifteen smart litter bins are about to be installed in trial locations across Suffolk in an effort to reduce littering on the county's trunk roads. The customised bins are designed for roadside use with a lit sign saying 'litter' a wider than usual aperture to make disposal of rubbish easier, bright orange bodies, reflective white signage and the clear message 'Keep Suffolk Beautiful'. Have your say on specialist education services

Suffolk's parents and carers of children and young people with SEND are being invited to have their say on proposed changes to the future commissioning of specialist education provision for children and young people between the ages of 5 and 25.

The 6 week consultation is asking for views from the public on two main issues: the key principals that will inform Suffolk's future commissioning of specialist education provision and express preference for one of three options, which each sets out a different commissioning strategy for the development of Suffolk's specialist education provision.

The options are:

Option 1 - to meet all additional growth for new specialist places through independent sector

Option 2 - to meet most of the additional growth by developing new special schools, using independent placements for a small number of children with very specialist needs

Option 3 - to meet the additional growth by a combination of new special support centres attached to existing main stream and specialist providers and new special schools, using independent placements for a small number of very specialist needs.
