SUFFOLK COUNTY COUNCIL - COUNCILLOR - T. J HAWORTH-CULF

She reported that she is still undergoing training for this role and that she will be sitting in on a number of various groups and committees.

T. J. reported on the local Covid cases and hope that all those eligible to take the vaccination will do so and that everyone will continue to keep themselves safe.

To help celebrate the Queen's Platinum Jubilee Councillor Haworth-Culf has offered up to £500 funding from her Locality Budget to help celebrate the occasion.

EAST SUFFOLK COUNCIL – DISTRICT COUNCILLOR RUSS RAINGER

Congratulations made to Russ for being elected as our East Suffolk District Councillor.

He quoted he is still finding his feet and is currently going through the IT induction process.

This week he will receive confirmation on which committees he will be covering in his role.

5. PARISH & GROUP ACTIONS

1) Neighbourhood Plan – Councillor Atkinson reported East Suffolk Council have responded after examining the Draft document and they have provided advice and comments on a number of issues which will now allow the Parish Council to proceed with the Neighbourhood Plan. ACTION: Parish Council NHPG

2) Heritage Group Hut – As the Parish Council covers the building and contents on their insurance policy, the ownership of the building was raised and it was agreed the Parish Council would like the TAHG to provide a document which explains if the Hut was gifted to the Parish Council they would have no financial responsibilities in the running and maintenance costs. Provide clarification should TAHG cease to exist the Parish Council have no obligation to continue to operate the building as a Heritage Centre.

ACTION: TAHG/Parish Council

3) Allotment Area - Having obtained quotations for the erection of a 1.2m fencing and an entrance gate around the Allotment Area, it was agreed to accept the lowest quotation received from Lee Hammond for the sum of £2290.00.

The Clerk reported an account has now been set up with Wave Water Company and the first bill is due in September.

4) New Grit Bin for the Mill Hill area, Councillor Seale has spoken with the residents and a suitable location has been decided.

5) The Thorpeness Village Fete is to be held on Saturday 7th August 12-3 pm at The Dolphin. Monies raised will be divided between Wardens Ness House and Coastal Erosion.
