The Jubilee Weekend events started on the Thursday with Pilgrims Group walk around the village and history talk at the Church, Quiz with Chris at the Parrot, Open day at Aldringham Court, Sunday a Service at Aldringham Church and Family Picnic on the Green with Maypole dancing, games and plenty of lovely cakes and food donated by the residents.

Wendy Sturmey along with residents of the Almshouses and others from the village enjoyed a tea party. Thanks to Wendy for all her efforts arranging the event.

All these Weekend Jubilee events held in the Parish were very successful and enjoyed by everyone who participated.

Councillor Atkinson has been advised by Sarah the Manager at Aldringham Court that the Parish Council and groups would be most welcome to make use of the Log Cabin situated on back of their car park. The building was erected and used by family members to visit their relatives during the Covid 19 restrictions.
