PARISH ACTIONS

- a) Following the request from a parishioner Councillor Seale has contacted the Parish Emergency Officer Roger Brown for his advice on a WhatsApp Group in the Parish for reporting emergencies. Roger has received guidance from East Suffolk Council and they advise it is not impossible to set up and maintain a group on WhatsApp whilst keeping within the law (GDPR), it would require someone to become the data holder and ensure the data remains accurate and secure. The Parish Council and the Emergency Officer agree they will be not be taking any action regarding this.
- b) Advertising Boards around the Parish. The Suffolk County Council Highway Advice Note ESE 01 Advertising Signs in the Highway Section 137 and 148 of the highways Act 1980 were referred to. Sections 143 and 149 give SCC powers to require the removal of and to remove structures from the highway. It was agreed a policy is needed and be posted on the Parish Council website.
