a) East Suffolk Council will be ceasing its operational contract with Norse on the 30th June 2023 the Council_has set up a Local Authority Trading Company (LATCo) called East Suffolk Services Limited (ESSL). The company will be wholly owned by the Council and will begin operations on the 1 July 2023.

The Council has also appointed a new Strategic Waste Team to be responsible for the development of future strategies for waste collection, recycling and street cleaning and the future contribution of council-owned open spaces to the green and health agenda The team will also be responsible for management of the service contract the Council will have with ESSL.
