1. Outstanding Newspapers

2. Himalayan Balsam Project

The River Stour Enhancement Project is working with an environmental research agency called CABI to develop a management solution for Himalayan Balsam. CABI have identified a species of rust fungus known to be a natural enemy to Himalayan balsam in its native range. The fungus underwent lengthy specificity testing within controlled laboratory conditions before it was approved for release in 2014. The AONB team is working with CABI looking for sites within the Dedham Vale as a trial site.
